Summary investment objective

To achieve a combination of income and growth by investing mostly in bonds (which are like loans that pay a fixed or variable rate of interest) issued by companies, governments or other bodies based, or carrying out much of their business, in Brazil. The bonds will be of any credit quality and typically priced in Brazilian Real; the value of your investment may therefore be affected by the movements, up or down, of that currency. The Fund is intended for investors who are willing to accept a high level of risk.

The Aberdeen Standard SICAV I - Brazil Bond Fund was launched on 18 June 2012 to facilitate a transfer of unitholders from the Credit Suisse Brazil Bond Fund (launched on 14 December 2007) to the Aberdeen Standard SICAV I SICAV. Prior to June 2012, the Fund's historic track record is that of the Credit Suisse Brazil Bond Fund, with Aberdeen's Global Emerging Markets Debt Team managing the fund since April 2012.

The comparator shown may be used for risk monitoring and portfolio construction purposes, as well as to provide a performance comparator; it is not an integral part of the Objective and Investment Policy for the fund and should not be considered as such.

Beta is a measure of the volatility of a portfolio in comparison to a benchmark index. Sharpe ratio measures risk-adjusted performance. Tracking error measures the divergence between the price behavior of a position or a portfolio and the price behavior of a benchmark. Information ratio is a ratio of portfolio returns above the returns of a benchmark to the volatility of those returns. R-squared is a statistical measurement that determines the proportion of a fund's return that can be explained by variations in the market, as measured by a benchmark index.
