Summary investment objective

To achieve income while preserving the value of the Fund by investing mostly in bonds (which are like loans that pay a fixed or variable rate of interest) priced in US Dollar and issued by companies. The bonds will typically have higher ratings, as defined by international agencies that provide such ratings; these may pay lower rates of interest than bonds with lower ratings but are more secure. The Fund will maintain a US Dollar currency exposure of at least 80% at all times and may invest up to 10% in bonds with lower ratings.
