Fund manager's report

Corporate bond markets delivered strong returns in March, driven both by falling credit risk premiums and collapsing government bond yields. Risk assets rallied, buoyed by a more dovish US Federal Reserve and optimism around a US/China trade settlement. Economic data continues to point to a global slowdown and earnings were somewhat mixed. The sterling investment grade index (ICE/BAML Corporate and Collateralised) generated a return of 2.6%, driven primarily by a 30 basis point fall in the government bond yield. The euro-denominated equivalent was up 1.4%, driven by a mix of falling yields and corporate bond spreads.

Sharp moves in yield curves boosted Fund performance, with overweight positions versus the benchmark in the US, UK and Europe. Asset allocation made a small negative contribution to performance. The allocation to student loans through the relatively new UK structure and the existing Sallie Mae bonds held back performance by around three basis points. Lloyds Bank bonds adversely affected performance. Dignity Finance continued its run of underperformance, partly on the confirmation of a Competition and Markets Authority investigation into pricing in the sector.
