Objectives and investment policy

Objective: To generate income and increase the value of the shareholder's investment over the long term (income and capital growth).

Investment policy: The Fund invests more than 50% of its total net assets in worldwide equities and bonds, with the remainder invested in other asset classes such as cash, property and infrastructure. The Fund's bond investments may be issued by governments, corporations and other large organisations, and may be any credit quality. The Fund may gain exposure to some assets by investing in other Funds (mainly those managed by the investment adviser or its affiliates).

The Fund has a wide range of investment powers. The Investment Manager has the flexibility to amend the investment allocation between different asset classes, in line with it's view on markets, in pursuit of the investment objective.

Fund manager's report

Market review

Global equities rebounded strongly in January, reversing some of the losses experienced towards the end of 2018. Dovish comments from the US Federal Reserve and an improved tone to US / China trade talks more than offset the impact of mixed economic newsflow which continues to point to a sluggish outlook for global growth.

Most other asset classes in the portfolio also achieved positive returns over the month with property and infrastructure to the fore. Investor sentiment continued to improve towards local currency emerging market bonds, which produced a strong return in January, buoyed by gains from most emerging market currencies. Notable positive contributions came from some of the higher-yielding countries such as South Africa, Turkey and Argentina.

Portfolio changes

We re-initiated a position in TwentyFour Income Fund (TFIF) at an attractive valuation. TFIF invests in a diversified portfolio of European and UK asset backed securities which we believe offers an attractive return for the level of risk
